

RESOLUTION 2026-xx  
Grand Chapter Royal Arch Masons of Alaska

WHEREAS finding a sufficient number of qualified Alaska Royal Arch Masons to fill all the elected and appointed offices of our Grand Chapter is becoming a challenge; and

WHEREAS for the most part, Grand Chapter Officers are ceremonial in nature and not essential to the function of the Grand Chapter.

NOW THEREFORE BE IT RESOLVED that the Constitution of the Grand Chapter of Royal Arch Masons of Alaska, Article III be now amended to reorganize the list of appointed Grand Officers as follows:

Who is eligible: except the Grand Chaplain, Sentinel, Masters of the First, Second, Third Veils, and Royal Arch Captain, no companion may serve as a Grand Officer who has not been installed as High Priest of a Chapter of Royal Arch Masons, and who is not at the time of his election and installation as such grand officer a member in good standing of a constituent chapter of this Grand Chapter.	4. Who is eligible: except the Grand Chaplain, Sentinel, Masters of the First, Second, Third Veils, and Royal Arch Captain, no companion may serve as a Grand Officer who has not been installed as High Priest of a Chapter of Royal Arch Masons, and who is not at the time of his election and installation as such grand officer a member in good standing of a constituent chapter of this Grand Chapter.

And BE IT FURTHER RESOLVED that this amendment will become effective upon adoption.
